- ✓ The replacement fee for a lost card is \$5.00. This card remains the property of SPAR and must be surrendered upon demand.
- ✓ Should any member debt not be honored by the member's depository, credit card Company, or bank for any reason the member is still responsible for that payment plus a service charge applied by SPAR. This is in addition to any service fee the member's credit card company or bank may charge. The membership is subject to termination if the debt is not paid.
- ✓ Waterpark rates are subject to change upon Annual review by SPAR Administration and Board of Commissioners.
