Reservation Rules:

1. **Canopy Party Pad Rentals are on a first come/first serve basis.** If the canopy is not posted as reserved it is available on first come, first served basis. Reservation is final after completed Reservation Rental Form is turned in and all fees are paid.
2. **Information discussed via phone, fax, email, in person, or other forms of communication DOES NOT reserve your party date.** Telephone reservations will NOT be accepted. Reservations are accepted in person with cash or credit card or debit card at SPAR Waterpark during normal operational hours.
3. **ALL Reservation Forms must be pre-approved prior to payment.** This will ensure safety, space is not overbooked, and enough staff is available for the night.
4. **Applicant agrees to arrive/depart at the scheduled pavilion rental time.** If a party overruns its rental agreement time, an additional \$40 will be charged.
5. **Upgrading a Canopy Party Pad time slot is available if space permits .**
7. **Party packages are sold "as is".** Refunds will not be given if you paid for a larger Canopy Party Pad than the actual number of people who attend party.
8. **Park Admission is not included with Canopy Party Pad Rentals.**

Cancellation Policy:

Groups that need to cancel their reservation must complete a Cancellation Request Form. Completed form must be received a minimum of 5 business days prior to scheduled event.

Notice must be given during Administrative office hours Monday – Friday 8:00AM – 5:00PM. Refund checks are mailed 7-10 business days after receipt of authorized Cancellation Request Form.

Weather Conditions:

- Staff has the right to cancel or close the facility based on unforeseen aquatic circumstances, weather, and/ or public safety concerns.
- Staff will communicate with the party host regarding weather closures and reschedule of canopy rental.
- Canopy rental cancelled by SPAR Waterpark due to weather conditions may reschedule or receive full refund.
- Canopy rental cancelled by party host will result in forfeit full amount of reservation fee and right to reschedule.
