### Inclement Weather

### Cancellations

### Conditions and Expectations agreement of SPAR WATERPARK

- Lessee of facility agrees and understands that SPAR will at its' discretion, and only its discretion, determine facility availability.
- Lessee should be on notice that SPAR will not be responsible for any monetary loss that lessee incurs and/or suffers as a result of SPAR postponing, delaying or canceling the facility rental for any reason at its' sole discretion with or without cause and/or explanation.
- Lessee realizes these factors exist and are under no obligation to lease or use these facilities, but does so being fully aware of the consequences and/or losses they may sustain due to SPAR's actions.
- Lessee agrees to notify all participants of SPAR's policies and that under no circumstances should they expect use of the facility that SPAR considers unavailable for any reason before and/or during the event.
- SPAR reserves the right to cancel this agreement for any reason at any time. If rules, regulations, and policies are not adhered to, SPAR has the right to terminate the rental and have the reserving party and guests escorted from the facility.

# SPAR WATERPARK party packages

## WEDNESDAY NIGHT Party Package Includes:

- **Reserved party area approximately 2 hours– 6:00-8:00PM**
- **Basic Park: 3 main slides, Lagoon Pool, Splash & Play areas**
- SPAR Party host to assist with set-up and clean-up
- Certified Lifeguards on duty throughout party
- Identification wristbands for your guests. Guests **MUST** wear them to enter. (You must provide a representative to pass out wristbands to guests prior to entry into facility.)
- Birthday person never waits in line on age/height appropriate slide(s)
- The luxury of being separated from general population. However, you will be grouped with several other parties. (About 500 other people)
- Note: SPAR reserves the right to cancel, postpone, or delay party due to low enrollment.

## Reservation Requirements:

**\$50 cash security/cleaning deposit + Rental Package fee = Reserved party in the park**



### **Security/ Cleaning Deposit**

- **\$50 CASH Only**
- Security: \$50.00 CASH security deposit AND Rental Package fee are required to officially reserve a rental date.
- Information discussed via phone/fax/email does not guarantee your reservation.
- Cleaning: Additional charges will be levied if necessary to cover special damage or cleaning problems. The reserved area should be clean before you leave. Place trash in receptacles provided. SPAR Party host will inspect area at end of party.
- The deposit may be claimed after 12 p.m. on the next business day following the event. If the deposit is not claimed within 45 days after the event, the deposit will be forfeited.

### **Rental Package Fee**

- **Minimum package fee is \$140 for 1-19 guests.**
- Acceptable form of payment: CASH, Visa, Master Card, Discover
- All guests who enter the facility must have a ticket regardless of participation.
- Both Deposit and Rental Package fee are due simultaneously to reserve party date.
- All reservation forms must be pre-approved prior to payment. This ensures safety and avoidance of overbooking facility.



### **Reservations Accepted**

- May 1st - 24th // SPAR Administrative offices // Monday - Thursday 8 a.m. - 5 p.m. // Friday 8 a.m. - 12 p.m.
- May 25th - July 31st, at SPAR Waterpark ticket offices, during operational hours.
- Information discussed via phone, fax, email, in person, or other forms of communication **DOES NOT** reserve your party date. Payment of \$50 cash security deposit and payment of rental package officially reserves your event.

## Party Night Policies:



### **Basic Park**

- Includes: 3 main slides, Lagoon Pool, Larry's Lazy River & Vortex, Splash & Play Island, and Patch's Splash Pad (Does not include the Raging River, Parrot Island, nor 2 new tunnel slides)
- Multiple parties are scheduled during each session.

### **Decorating**

- A maximum of two people may enter and set-up from 5:35pm to 6:00pm.
- No affixing of any items to posts, concrete, canopy, outlets, or trash cans.

**Clean up** time is available until 8:15pm.

### **Upgrading a Party Package**

- Available IF space permits
- Must be paid in full 7 business days prior to the party date
- If the number of people exceeds the original amount paid, you will be required to pay \$7 per person
- Upgrades during the event are limited due to safety and special accommodations.
- The deposit cannot be applied toward the balance of rental package upgrades.

### **Downgrading a Party Package**

- Party packages are sold "as is".
- Refunds will not be given if you paid for a larger Party Package than the actual number of people who attend party.



## Cancellations:

1. Groups that need to cancel their reservation must complete a Cancellation Request Form.
2. Completed form must be received a minimum of 5 business days prior to scheduled event.
 

5 or more business days	deposit refunded; full amount of rental fee will be refunded
4 or less business days	deposit refunded; only half the rental fee will be refunded
3. Notification accepted during Administrative hours: Monday – Thursday 8 a.m.– 5 p.m. // Friday 8 a.m. –12 p.m.
4. Refund checks are mailed 7-10 business days after receipt of authorized Cancellation Request Form.
5. **Lessee should be on notice that SPAR will not be responsible for any monetary loss that lessee incurs and/or suffers as a result of SPAR postponing, delaying or cancelling the facility rental for any reason at its' sole discretion with or with out cause and/or explanation.**



## Inclement Weather:

SPAR Administration will notify the person responsible for party by 3:30PM on date of party if a "rain out" is determined. A party "rained out" will be rescheduled at the earliest Wednesday available at SPAR Waterpark's discretion.



## Food and Beverages:

- Concession stand is open during Wednesday night parties.
- ICEES, fountain drinks, candy, chips can be pre-ordered.
- You may bring a birthday cake, beverages, and food such as pizza and/or snacks into SPAR WATERPARK for Wednesday night parties only.
- Ice chests are permitted, but subject to search at gate.
- Unacceptable Items: Glass containers, alcohol, barbeque pits, tobacco products or drugs, boiled crawfish, piñata, buckets of ice cream



## Code of Conduct:

- Person responsible for rental is responsible for the conduct of their guests whether swimming or not.
- State Law requires riders to obey all warnings and directions and behave in a manner that will not cause or contribute to injuring themselves or others. Riders should report all injuries before leaving the event premises. -RS Code 1485.7



## Reservation Checklist!

- Check availability of date.
- Complete Rental Application.
- Pay CASH Deposit & Rental Package Fee.
- Clearly understand all rules, the cancellation policy, and rain out policy.
- Pay for upgrade, space permitting, 7 business days prior to event.
